ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Runnels County, Texas, that such Treasurer's Report for the month ended March 31, 2017, be and hereby is, approved and accepted as correct.


