ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

 NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Runnels County, Texas, that such Treasurer's Report for the month ended April 30, 2022 be and hereby is, approved and accepted as correct.  
 FURTHER, as specifically required by statute, the Commissioners' Court states that the amounts received and paid from each fund since the preceding County Treasurer's Report and the balances remaining in the County Treasurer's custody at the end of the reporting period are as follows:




